SASEC Trade Facilitation Week: Sanitary/ Phytosanitary and Technical Barriers to Trade 1-3 December 2014: Bangkok, Thailand

The SASEC Trade Facilitation Week: Sanitary/Phytosanitary (SPS) and Technical Barriers to Trade (TBT) meeting discussed current and potential contributions of international organizations in harmonization of standards, setting of regional standards, and facilitation of mutual recognition arrangements/conformity assessments. The meeting also reached broad agreement on the terms of reference for national diagnostics studies in each of the SASEC countries identifying priority potential export items facing SPS and TBT measures, and broadly endorsed the establishment of a SASEC SPS and TBT Subgroup.

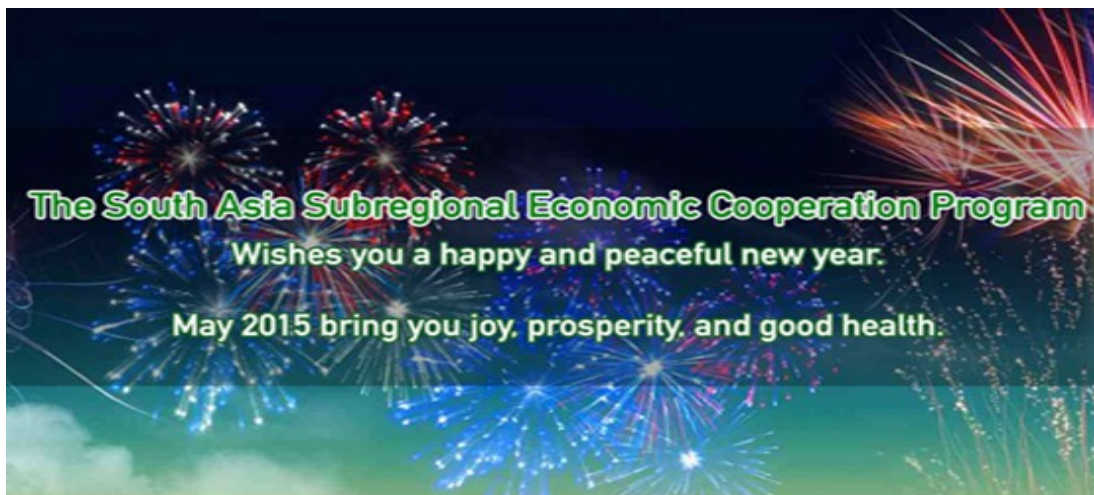

ADB to Finance Bhutan's Second Green Power Development Project through PPP **15 December 2014: Manila, Philippines**

ADB approved financing support to develop the Nikachhu hydropower plant—a run-of-the-river hydropower plant—in central Bhutan totaling \$120.5 million in a package of loans and grants, through a public-private partnership. With expected capacity of 118-megawatt, the [Second Green Power Development Project](#) is expected to boost renewable energy generation in Bhutan, and further expand cross-border power trading in the region.

ADB to Fund Infrastructure and Energy Projects in Bangladesh **11 December 2014: Dhaka, Bangladesh**

ADB, along with other bilateral donors, will fund \$4.5 billion worth of infrastructure and energy-related projects in Bangladesh. The Economic Relations Division of the Bangladesh Ministry of Finance is seeking funding from ADB for four out of nine projects – improvement of water management infrastructure of polder 56/57 in Bhola district; Khulna 750-850 MW liquefied natural gas-based combined cycle power plant project; Solar Irrigation Pump Project; and capacity upgradation of Bheramara HVDC station to import an additional 500 MW power from India.

Bhutan Trucks May Now Enter Bangladesh **9 December 2014: Dhaka, Bangladesh**

Bhutanese trucks carrying import/export cargo are now able to enter Bangladesh via India, according to Bangladesh Commerce Minister Tofail Ahmed during a visit to Bhutanese Prime Minister Tshering Tobgay on 7 December 2014. Most import/export activity between Bhutan and Bangladesh takes place through Bangladesh's Burimari land port, on the Bangladesh-India border, and many of the Bhutanese trucks return to Bhutan without cargo from Bangladesh. The new agreement will allow trucks to carry products directly from Bangladesh for import to Bhutan.

Bilateral Talks Between Bangladesh and Bhutan 6 December 2014: Dhaka, Bangladesh

Bhutan's Prime Minister Tshering Tobgay has agreed with Bangladesh Prime Minister Sheikh Hasina to close trade gaps by exporting more goods and expanding the list of products free of tax and duty enjoyed by both countries. Bhutan's total trade volume with Bangladesh is worth about \$25.6 million. Bangladesh is the only country in the SAARC region in which Bhutan has a trade surplus.

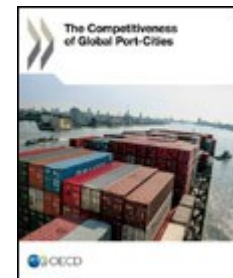

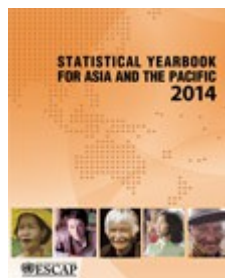
