Objectives:	<ol style="list-style-type: none"> 1. Consider the impact of electronic exchange of data on the functioning of SASEC Customs administrations including potential benefits 2. Assess ICT hard and soft infrastructure including transmission capacity, software, hardware and interoperability of IT solutions 3. Assess the most appropriate model for the data exchange including the use of the WCO Data Model 4. Analyze the experiences of other countries that have successfully undertaken electronic exchange of data 5. Evaluate the means and manner of resolution of the issues to enable successful Customs to Customs (C2C) electronic exchange of data 6. Discuss and document knowledge gaps and capacity building needs 7. Determine the subregional institutional mechanisms to enable data exchange including IT architecture, legal and administrative issues.
Expected Outcomes:	<ol style="list-style-type: none"> 1. Thorough understanding of the critical issues to be resolved for operationalizing C2C electronic data exchange in SASEC; 2. Develop a model for conducting a pilot project on the regional electronic exchange of data along with an implementation plan including the processes (import, transit, etc.) to be covered, the manner of use of the exchanged information to benefit Customs and Trade, benchmarking indicators, and criteria for determining success of the pilot; and 3. Prepare a roadmap for executing the pilot. <p>The implementation plan and the road map to achieve the plan shall form the basis of an agreed report to the 5th meeting of the SASEC Customs Subgroup in May 2016 concerning the feasibility of a regional Customs data exchange project and its various challenges.</p>

It would include at least the following:</i></p> <ul style="list-style-type: none"> • <i>SASEC countries to be part of the pilot</i> • <i>Type of exchange</i> • <i>Legal basis</i> • <i>Subregional institutional basis for a project</i> • <i>Customs procedures in scope (e.g., export goods declaration)</i> • <i>Data set/data clusters and data standard (e.g., WCO Data Model)</i> • <i>Messaging</i> • <i>ICT hard and soft requirements</i> • <i>Basic business rules (e.g., pull/push)</i> • <i>Appropriate level architecture</i> • <i>High level description of costs</i> • <i>Estimated benefits</i> • <i>Timelines for commencing the pilot and the interim steps</i> • <i>Notional capacity building requirements</i>
