17 March 2023: Manila, Philippines

Road development is fundamental to boosting economic activity in Nepal and is a key element for strengthening growth and social inclusion. This case study undertaken by ADB looks at the Subregional Transport Enhancement Project and how it is improving access to goods and services, facilitating trade and cooperation, creating opportunities for small business owners, and empowering women in rural communities.

ADB Submits Feasibility Study on the North East Economic Corridor

16 March 2023: New Delhi, India

ADB submitted a feasibility study on the North East Economic Corridor to the Ministry of Development of North Eastern Region, and the Rajya Sabha (Council of States) was informed. Features of the report include emphasis on development of transport, urban, and energy infrastructures, as enablers for equitable economic development for India's northeastern region; and envisages multimodal transport network at three levels: (i) within India's northeastern region; (ii) between the northeastern region and the rest of India with an additional route through Bangladesh; and (iii) with neighboring countries to enhance South Asia-Southeast Asia connectivity.

Agartala-Akhaura International Railway Connectivity Project Reaches 88% Completion

29 March 2023: Tripura, India

The ongoing construction of the Agartala (India)-Akhaura (Bangladesh) international railway connectivity project has reached over 88% completion. The work is expected to be finished in the next 5-6 months, according to Mr. Sushanta Chowdhury, Minister of Food, Civil Supplies and Consumer Affairs, Transport and Tourism of Tripura.

India and Sri Lanka to Start Ferry Service

26 March 2023: Colombo, Sri Lanka

India and Sri Lanka are set to begin a passenger ferry service in April 2023. The ferry service between Karaikal, Puducherry, India, and Kankesanthurai, Jaffna, Sri Lanka, would commence on 29 April under the new passenger ferry program. The ferry will have a capacity of 150 passengers, and each passenger would be given 100-kg baggage allowance. The cost of one-way travel is around \$50.

Bangladesh and Bhutan Sign Agreement on the Movement of Traffic-in-Transit and Protocol

22 March 2023: Thimphu, Bhutan

The Governments of Bangladesh and Bhutan signed the "Agreement on the Movement of Traffic-in-Transit and Protocol." This will open multimodal transit facilities to landlocked Bhutan, providing them access to Mongla, Payra, and Chattogram ports of Bangladesh for the movement of their imported and export-oriented goods.

Foreign direct investment is effective in promoting economic development according to International Chamber of Commerce (ICC) Bangladesh President Mahbubur Rahman, speaking at the webinar "Into the Centenary Year: ICC Court visits ICC Bangladesh." Bangladesh is South Asia's second-largest economy and is slated to graduate from the least developed country (LDC) category in November 2026.

Bangladesh Prime Minister Sheikh Hasina remarked that India can utilize Bangladesh's Chattogram and Sylhet ports. Access to the two ports would mutually benefit both countries, stressed the Prime Minister.

He noted that there is a huge potential for mutual cooperation between the two countries in areas including energy, tourism, education, migration, and connectivity.


