SASEC Transmission Line and Substation Inaugurated by Nepal Prime Minister Oli 6 July 2021: Kathmandu, Nepal

A 132-kilovolt (kV) Samundratar-Trishuli transmission line and a 132/33-kV Samundratar substation under the South Asia Subregional Economic Cooperation (SASEC) program were inaugurated by Nepal Prime Minister KP Sharma Oli. The 25.74-kilometer transmission line will be able to transmit up to 270 megawatts of electricity. The transmission line and substation were constructed with funding totaling NPR1.55 billion (approximately \$12.9 million) from the Government of Nepal, the Asian Development Bank (ADB), and the European Investment Bank. **Read More**

A workshop was held virtually to discuss the Study on Port Logistics and Hinterland Connectivity. It presented the findings for addressing inefficiencies identified in the study, and sought stakeholders' feedback. The virtual workshop underscored recommended infrastructure and technological interventions to enhance the efficiency of port logistics and connectivity in the region. The event was attended by 52 participants, including representatives from port authorities, customs, planning, shipping and transport authorities, and other related ministries in Bangladesh, India, and Maldives. This workshop is part of ADB's efforts to advance cooperation and integration in the SASEC maritime sector and promote globally competitive and environmentally sustainable ports in the SASEC subregion.

Bhutan's Customs Amendment Act 2021 Takes Effect

23 July 2021: Thimphu, Bhutan

Bhutan's Customs Amendment Act 2021 has been put into effect on 23 July 2021. The Ministry of Finance issued a notification that it will refund the customs duty levied in excess of the new rates from the day the bill was presented in Parliament on 31 May 2021 in compliance with the Public Finance Act.

India Central Board of Indirect Taxes and Customs, Maldives Customs Service Ink Data Sharing Deal

22 July 2021: New Delhi, India, and Malé, Maldives

India's Central Board of Indirect Taxes and Customs signed a data sharing agreement with the Maldives Customs Service that will enable automatic exchange of customs data between the two countries in real time. This deal with Maldives allows the exchange of information on consignments before their arrival. It aims to reduce the time for customs clearance and discourage misdeclaration of trade and/or smuggling.

India will export 150,000 tonnes of rice to Bangladesh as agreed in the recent bilateral trade agreement signed by Bangladesh and India. Essar Shipping has been contracted to ship the rice.

Joint Efforts Opening New Avenues of Cooperation in Central, South Asian Countries

16 July 2021: Tashkent, Uzbekistan

Combined efforts by countries to establish good connectivity has opened new avenues of cooperation in Central Asia and South Asia, according to Mr. AK Abdul Momen, Minister of Foreign Affairs of the Government of Bangladesh. Mr. Momen was speaking at the plenary session of the conference "Central and South Asia: Regional Connectivity— Challenges and Opportunities."

Interim Arrangement Enables Import of Vegetables from Bhutan to India

14 July 2021: Thimphu, Bhutan, and New Delhi, India

The Government of India has implemented an interim arrangement to allow the import of seven types of vegetables chilli, beans, cabbage, cauliflower, carrot, peas, and soybean—from Bhutan that were not included in the Plant Quarantine (Regulation of Import into India) Order, 2003, and facing the hurdle of a required customs clearance. According to the notification issued by the Indian Embassy in Thimphu, the crops could be imported through the plant quarantine station in Jaigaon, India. A plant protection officer will be posted by the Government of India in Jaigaon to facilitate the plant quarantine works.

India, Nepal Revise Railway Service Agreement

9 July 2021: New Delhi, India, and Kathmandu, Nepal

The Note Verbales and Letter of Exchange for the revision of the Railway Service Agreement between India and Nepal was signed and took effect on 9 July 2021. This move is set to boost rail transport between the two neighboring countries. The revision (i) authorizes all cargo train operators, including public and private container train operators, automobile freight train operators, special freight train operators, and/or any other operator authorized by the Indian Railways, to utilize the Indian railway network to carry Nepal-bound freight; (ii) allows different categories of wagons to carry cargo to and from Nepal; and (iii) authorizes wagons owned by the Nepal Railway Company to carry Nepal-bound freight over the Indian Railways network as per standards and procedures of Indian Railways.

Upper Tamakoshi Hydropower Project Starts Power Generation

5 July 2021: Kathmandu, Nepal

Nepal's largest hydropower project, the 456-megawatt Upper Tamakoshi Hydropower Project, began operating one of its six 76-megawatt units. The project is set to turn Nepal into a power surplus country during the wet season once it starts generating power from all its six units to the national grid. As a power surplus country, it will be capable of exporting electricity.


