SASEC Investment Grows to \$10.74 billion

31 December 2017: Manila, Philippines

The SASEC Program ended 2017 on a high note, having launched the SASEC Vision, welcomed Myanmar as a full member of SASEC, invested almost \$1 billion in three new projects during the year, and seen total program investment rise to \$10.74 billion for 49 loan/grant projects. SASEC projects approved in 2017 include the Bangladesh: SASEC Dhaka-Northwest Corridor Road Project, Phase 2 - Tranche 1; Nepal: SASEC Customs Reform and Modernization for Trade Facilitation; and Nepal: Regional Urban Development Project.

The Bangladesh National Board of Revenue held a Systems-based Postclearance Audit (PCA) Training of Trainers, explaining the international agreements that endorse PCA, highlighting the role of senior managers in a PCA program, and including practical sessions on interviewing, accounting, and auditing for systems-based PCA.

15 December 2017: Siliguri, India

This Inception Meeting on the SASEC Customs Subgroup Subregional Project 3 – "to institutionalize border meetings among Customs authorities at major border crossing points" – agreed to conduct a trial project and convene a subregional meeting for participating Customs administrations every six months and identified a Contact Point at each of the Land Customs Stations.

14-15 December 2017: Colombo, Sri Lanka

This Workshop discussed the potential of developing Sri Lanka as a Liquid Petroleum Gas (LPG) Transshipment Hub, and small-scale liquefied natural gas (LNG) value chain in the South Asia subregion. Participants agreed to undertake studies on (i) regulatory reforms in Sri Lanka to develop and expand an LPG hub, and (ii) meeting LNG demand in the subregion.

Southwest Bangladesh Economic Corridor Comprehensive Development Plan – Final Report Dissemination Seminar

11 December 2017: Dhaka, Bangladesh

The Asian Development Bank organized a seminar to present findings of the Comprehensive Development Plan for the envisaged Southwest Bangladesh Economic Corridor (SWBEC). Key findings highlight that developing the SWBEC will enable the region's industrial output to reach \$148 billion by 2050, and employment in the southwest region will increase to 35 million within the same period, with 25 million new jobs to be generated from corridor-induced activities.

SASEC SPS-TBT Diagnostic Study for India: National Validation Meeting

11 December 2017: New Delhi, India

This Meeting shared the draft final findings and recommendations of the sanitary-phytosanitary (SPS) and technical barriers to trade (TBT) national diagnostic study for India. Outcomes of the validation meeting in India included presentation of patterns of India's trade with other SASEC countries and identification of products with potential for export from India to other SASEC countries, noting SPS and TBT measures applied to the products, and which products fall under the SAFTA Sensitive List; an overview of the legislative environment, of institutional arrangements and capacities, and of infrastructure capacities and constraints, for both SPS and TBT, noting current gaps compared with international best practice; and presentation of India's ongoing efforts and initiatives to address SPS-TBT-related issues and upgrade existing procedures.

SASEC SPS-TBT Diagnostic Study for Maldives: National Validation Meeting

7 December 2017: Male, Maldives

This Meeting shared the draft final findings and recommendations of the sanitary-phytosanitary (SPS) and technical barriers to trade (TBT) national diagnostic study for Maldives. Outcomes of the meeting included presentation of patterns of Maldives' import and export trade with other SASEC countries, identification of potential export and import products for India and Sri Lanka, noting their respective SPS-TBT measures, as well as discussion on wider potential export diversification; an overview of the legislative environment, of institutional arrangements and capacities, and of infrastructure capacities and constraints, for both SPS and TBT in Maldives; and identification of various and specific standards, regulations, and procedural obstacles that impede trade of the identified potential export commodities from Maldives with India and Sri Lanka, and clarification whether these obstacles are SPS-TBT-related, or due to other non-tariff measures and barriers.

Bhutan Launches Customs Rules and Regulations 2017

27 December 2017: Thimphu, Bhutan

Bhutan's Ministry of Finance launched the Customs Rules and Regulations (CRR) of Bhutan 2017, defining provisions including classification of goods, Customs valuation, temporary admission, clearance procedures, and authorized compliant traders. SASEC assisted Bhutan's Department of Revenue and Customs in developing the Customs Act and the CRR of Bhutan 2017, under a national technical assistance project, financed by the Japan Fund for Poverty Reduction and administered by the Asian Development Bank.

SASEC Project to Increase Capacity of Nepal Transmission Lines

18 December 2017: Manila, Philippines

An ADB-funded project is upgrading power lines and substations in 49 locations in Nepal to enhance the country's electricity distribution system. The \$191 million SASEC Power System Expansion Project aims to increase the load-bearing capacity of transmission lines in Nepal.

Nepal Switches on its Largest Wind-Solar Hybrid Power System

12 December 2017: Manila, Philippines

Nepal switched on its largest wind-solar hybrid power system in Hariharpurgadi village, Sindhuli district. The subproject, funded by an ADB grant under the South Asia Subregional Economic Cooperation Power System Expansion Project, produces 110 kWh of electrical energy per day, to help meet Hariharpurgadi's electricity demand of 87 kWh per day.

Power Purchase Agreement between India and Nepal Extended

27 December 2017: Kathmandu, Nepal

The power purchase agreement between the Nepal Electricity Authority and the NTPC Vidyut Vyapar Nigam of India was extended by three months, from 1 January to end of March 2018. This allows Nepal to import up to 160 megawatts of electricity through the Dhalkebar-Muzaffarpur cross-border transmission.

Myanmar Launches Authorized Economic Operators Program

23 December 2017: Yangon, Myanmar

Myanmar Customs Department met with import and export companies, freight forwarders, and government departments to raise public awareness for its Authorized Economic Operator (AEO) program, initiated in line with the Association of Southeast Asian Nations (ASEAN) Trade in Goods Agreement, the World Trade Organization Trade Facilitation Agreement, and World Customs Organization international standards.

River Dredging Planned for Development of Year-round Bangladesh-India Waterway Navigation

18 December 2017: New Delhi, India

India's Ministry of Shipping reported planned dredging works in the Zakiganj-Ashuganj section of the Kushiyara river and in the Sirajganj-Daikhowa section of the Jamuna river to help develop year-round navigation. Dredging will be executed by the two countries, subsequent to the decision taken in the meeting of the Shipping Secretaries in December 2016.

India Fast-tracks International Highways in South Asia

18 December 2017: New Delhi, India

India's Ministry of Road Transport and Highways (MoRTH) will prioritize plans to construct 2,000 kilometers of roads linking India's major highway corridors to international trade points in South Asia. MoRTH Minister Nitin Gadkari highlights that this plan, worth Rs 25,000 crore, will facilitate export/import trade with Bangladesh, Bhutan, Myanmar, and Nepal. The Ministry also took steps to operationalize the BBIN MVA.

14 December 2017: Dhaka, Bangladesh

The Asian Development Bank (ADB) will lend Bangladesh \$6 billion during 2018-2020, in support of 43 projects to generate inclusive growth and help the country achieve its Sustainable Development Goals. ADB affirmed its long-term development partnership with Bangladesh on 12 December 2017 as it marked 50 years of operations.

Trade is lifting developing Asia's growth, according to the Asian Development Bank Outlook (ADO) Supplement: A Firmer Growth Outlook for Asia. Despite downward revisions from previous projections, South Asia is still forecast to remain the fastest growing subregion in Asia and the Pacific.

Trade Facilitation Must Remain a WTO Priority

13 December 2017: Buenos Aires, Argentina

Trade facilitation must remain a priority for the WTO and its members, said WTO Deputy Director-General Yi Xiaozhun at the 11th WTO Ministerial Conference, adding that the WTO Trade Facilitation Agreement will especially benefit least developed countries. WTO members vowed to continue negotiations in all areas, and issued joint ministerial statements on investment facilitation, small and medium size enterprises, and e-commerce.

India Proposes \$1 Billion LoC to Boost Connectivity with ASEAN

11 December 2017: New Delhi, India

India has proposed a \$1 billion line of credit (LOC) to strengthen sea, air, and road connectivity with the Association of Southeast Asian Nations (ASEAN), according to the Ministry of Road Transport and Highways, India. India and Myanmar are working together to upgrade infrastructure in the border areas, including the India-Myanmar-Thailand (IMT) Trilateral Highway, and the Kaladan Multimodal Transit Transport Project.






