Electronic Cargo Tracking System to Help Ease Transit of Nepal-bound Cargo

14 January 2018: Kathmandu, Nepal

The Cabinet of Nepal has approved the modality of the Electronic Cargo Tracking System (ECTS). Following this, Nepal's Ministry of Commerce (MoC) has begun preparations for ECTS implementation with the assistance of ADB. Mr. Ravi Shanker Sainju, Joint Secretary, MoC, is hopeful that the ECTS will help control the turnaround time of shipping line containers, and significantly reduce the delay and cost of trade. He stressed that if Nepal can minimize time consumed in trade, cost of goods can go down, and create prospects for industrialization.

He urges WCO and its members to contribute to building business environments that are enabling, safe, and fair and sustainable.

The Government of Bhutan is moving forward with Detailed Project Reports for pipeline hydropower projects in the country, including hydropower joint ventures with the Government of India. Bhutan aims to generate another 5,178 megawatts by 2025 from these pipeline projects, including the 1,125 MW Dorjilung project, 2,560 MW Sunkosh project, and 2,640 MW Kuri Gongri Project.




