

Bangladesh SASEC Chattogram-Cox's Bazar Railway Project to Get Tranche 2 Financing

23 May 2019: Dhaka, Bangladesh

The Asian Development Bank (ADB) and the Government of Bangladesh signed an agreement for Tranche 2 financing of the Bangladesh: SASEC Chattogram (Chittagong)-Cox's Bazar Railway Project, Phase 1. The \$400 million loan support from ADB forms the second part of the \$1.5 billion ADB railway investment program.

ADB to Help Maldives Establish A National Single Window

31 May 2019: Manila, Philippines

ADB approved the proposed financing for the Maldives: SASEC National Single Window Project worth \$11 million. This project will introduce a single electronic platform in Maldives to improve the speed and efficiency of cross-border control procedures by employing the latest technology. This project will improve the trade environment of Maldives, and help expand its trade with partners in the region, including India and Sri Lanka. Establishing a national single window allows traders to fulfill all import, export, and transit-related regulatory requirements via a single entry point, reducing delays and lowering costs associated with the clearance of goods.

Bangladesh Prime Minister Hasina Opens SASEC Flyovers, Underpasses, Bridges

25 May 2019: Dhaka, Bangladesh

Bangladesh Prime Minister Sheikh Hasina inaugurated the Konabary and Chandra flyovers; the Kaliakair, Deohata, Mirzapur, and Gharinda underpasses; and the Kadda-1 and Bimail bridges on the Joydebpur-Chandra-Tangail-Elenga highway under the South Asia Subregional Economic Cooperation (SASEC) Road Connectivity Project.

ECTS Reduces Need for Indian Customs Clearance on Nepal's Third Country Imports via Rail

7 May 2019: Kolkata and Visakhapatnam, India

Clearance by Indian customs authorities will no longer be required on Nepal's third country imports onboard container rail cargo with the implementation of the electronic cargo tracking system (ECTS) at the ports of Kolkata and Visakhapatnam. Kolkata port authorities are also planning to introduce ECTS for cargo transshipment via roads, in phases.

Sri Lanka, India, and Japan to Jointly Develop Colombo Port's East Container Terminal

28 May 2019: Colombo, Sri Lanka

The Governments of Sri Lanka, India, and Japan signed a Memorandum of Cooperation to jointly develop Colombo Port's East Container Terminal. The Sri Lanka Ports Authority highlights that this project reflects the longstanding good will and cooperation among the three countries. Sri Lanka, India, and Japan pledged to work together for further development of the Colombo Port, and contribute to regional prosperity and stability of global trading networks.

Bangladesh Foreign Minister Requests ADB Support in Building Regional Infrastructure

23 May 2019: Dhaka, Bangladesh

Mr. Manmohan Parkash, Country Director of Bangladesh Resident Mission of the ADB, called on Mr. AK Abdul Momen, Foreign Minister of the Government of Bangladesh. In the meeting, the Foreign Minister stressed Bangladesh's appreciation for strengthening regional connectivity through the ADB-supported SASEC program. He further requested the ADB Country Director for continued support in building regional infrastructure. These include projects on hydropower generation and cross-border power transmission and distribution.

Sri Lanka Exports to SASEC Countries Up by 8%

Sri Lanka's exports to SASEC member countries have increased from 6% to 8% in the 13-year-period from 2002 to 2015. The study looks at ways to help Sri Lanka exports by establishing laboratory facilities for testing new products and by developing the country's regulatory, institutional, and capacity frameworks

It is eyeing \$500 million in annual exports, and will facilitate coastal shipping services between Hambantota and Colombo Ports.


