SASEC Portfolio Tops \$9 Billion

1 December 2016: Manila, Philippines

The SASEC project portfolio has surpassed the \$9 billion mark with the approval of Nepal's SASEC Roads Improvement Project, worth \$256.5 million. There are now 44 SASEC investment projects worth a cumulative \$9.13 billion. During 2016, seven projects have been approved for a total of \$2.37 billion: Bangladesh's SASEC Chittagong-Cox's Bazar Railway Project – Tranche 1, and the Railway Sector Investment Program – Tranche 4; India's Visakhapatnam-Chennai Industrial Corridor Development Program – Project 1, and the Bihar New Ganga Bridge Project; Bhutan's additional financing for the Air Transport Connectivity Enhancement Project, as well as the SASEC Transport, Trade Facilitation, and Logistics Project; and Nepal's SASEC Roads Improvement Project. The SASEC transport sector now comprises 31 active projects worth \$7.30 billion, followed by the energy sector with 10 projects worth \$1.28 billion, 1 trade facilitation project worth \$48 million, and 1 ICT project worth \$18 million.

SASEC Roads Improvement Project to Boost Nepal's Transport Connectivity and Export Competitiveness

1 December 2016: Manila, Philippines

The Asian Development Bank has approved a loan for \$187 million to Nepal for the SASEC Roads Improvement Project, which will upgrade transport connectivity and bring transformational gains by making social services more accessible, opening up previously untapped economic opportunities, and supporting trade between Nepal and India.

IMT Friendship Motor Car Rally Highlights IMT Connectivity

2 December 2016: Bangkok, Thailand

An India-Myanmar-Thailand (IMT) Friendship Motor Car Rally, beginning in New Delhi, India and culminating in Bangkok, Thailand, has highlighted potential benefits of intra-regional connectivity and integration, and sensitized stakeholders on the all-weather road that will make travel from New Delhi to Bangkok by road possible.

Nepal's Third Country Trade through Vizag Port Moves Forward

21 November 2016: Kathmandu, Nepal

A notification for moving export and import cargo to and from Nepal through Visakhapatnam (Vizag) Port in Andhra Pradesh, India, was issued by the Nepal Department of Customs. This follows the go-ahead given by the Central Bank of Nepal to issue letters of credit to clients using Vizag Port to bring in trade. Furthermore, the Government of Nepal is considering establishing a consulate in Andhra Pradesh to ensure more efficient utilization of Vizag Port.

East Coast Economic Corridor to Include Odisha

18 November 2016: Visakhapatnam, India

The State Government of Odisha will prepare a conceptual development plan for the first phase of the East Coast Economic Corridor (ECEC) by March 2017. Odisha has been included in the ECEC following discussions between officials of the Government of India and the Asian Development Bank.

Bangladesh-Nepal Road Route Survey to be Held in December

15 November 2016: Dhaka, Bangladesh

Government officials of Bangladesh and Nepal will conduct a joint survey on a potential road route under the Bangladesh-Bhutan-India-Nepal (BBIN) Motor Vehicle Agreement (MVA), starting from 5 December 2016. It will check road conditions, length of travel, and necessary infrastructure to ensure seamless movement of vehicles.

The new India-Bhutan Trade, Commerce and Transit Agreement was signed on 12 November 2016 in Thimphu, Bhutan. The bilateral Agreement focuses on promoting trade between the two countries through trade facilitation, improving trade procedures, and adding exit and entry points to facilitate Bhutan's third-country trade.

10 November 2016: Colombo, Sri Lanka

Bangladesh and Sri Lanka have agreed to sign a free trade agreement to enhance bilateral trade between the two countries. This decision came out of the Fifth Joint Economic Cooperation Session between Bangladesh and Sri Lanka, and reflects an eagerness of both countries to improve trade volumes.

Online Alert System for SPS/TBT Notifications Launched

8 November 2016: Geneva, Switzerland

EPing, an online alert system for updates on the latest information on regulatory requirements for international trade, was launched by the United Nations Department of Economic and Social Affairs, the World Trade Organization, and the International Trade Centre. The system enables access to WTO member notifications on Technical Barriers to Trade (TBT) and Sanitary and Phytosanitary (SPS) measures, and facilitates dialogue among the public and private sector in the early stages of potential trade issues.

The MOU extends the provision to operate border haats to five years, increases the number of vendors allowed, and sets a \$200 purchase limit per person.




