# Planned Railway Lines Connecting Bhutan and India to Strengthen Regional Connectivity

## 30 September 2025: Hyderabad, India

India will construct two new railway lines to link India and Bhutan. One railway link will connect Banarhat in West Bengal, India, to Samtse, Bhutan, and another will connect Kokrajhar in Assam, India, to Gelephu, Bhutan. The projects will strengthen transport connectivity and economic integration in the region.

#### 27 August 2025: Thimphu, Bhutan

The sixth and final unit of the Punatsangchhu-II Hydropower Project was successfully synchronized with Bhutan's national grid on 27 August 2025, bringing the 1,020 MW project to full operational capacity. As one of the largest and most significant joint hydropower ventures between Bhutan and India, the project stands as a testament to the strong partnership between Bhutan and India in renewable energy development.

## 25 August 2025: Kathmandu, Nepal

The Fifteenth Meeting of the Governing Board of the South Asian Association for Regional Cooperation (SAARC) Cultural Centre convened at the Galle Face Hotel, Colombo, Sri Lanka, on 19 to 20 August 2025. The meeting was attended by officials from the People's Republic of Bangladesh, the Royal Government of Bhutan, the Republic of Nepal, and the Democratic Socialist Republic of Sri Lanka. Officials from the Republic of India, the Republic of Maldives, and the Islamic Republic of Pakistan attended virtually.

#### 15 August 2025: Kathmandu, Nepal

Mr. Vikram Misri, Foreign Secretary of the Government of India, visited Nepal on 17-18 August 2025 and met with leaders including Nepal Prime Minister K. P. Sharma Oli, Nepal President Ramchandra Paudel, and Mr. Arzu Rana Deuba, Foreign Minister of the Government of Nepal. Their discussions focused on expanding cooperation in socioeconomic, technological, and connectivity sectors.

## Nepal to Export Additional 200 MW of Electricity to India

#### 11 August 2025: Kathmandu, Nepal

The Government of India approved the purchase of an additional 200 MW of electricity from Nepal, effective 11 August to 31 October 2025. This raises Nepal's total export capacity to India to 1,010.9 MW. Nepal's overall export capacity now stands at around 1,051 MW, including its 40 MW export to Bangladesh.

# **Bhutan Begins Construction of Dorjilung Hydropower Project**

#### 8 August 2025: Thimphu, Bhutan

Bhutan has officially initiated construction for the 1,125 MW Dorjilung Hydropower Project. The project, a joint venture between Bhutan's Druk Green Power Corporation (DGPC) and India's Tata Power Company Limited, marks a strategic shift from purely government-led initiatives to a partnership model involving private capital and multilateral finance, with the World Bank as the lead financier.

The Governments of Bangladesh and Nepal are negotiating a Preferential Trade Agreement (PTA) to reduce tariff and non-tariff barriers and address the widening trade deficit between the two countries. At a roundtable discussion organized by the Centre for Policy Dialogue, Mr. Ghanshyam Bhandari, Nepal's Ambassador to Bangladesh highlighted cooperation potential and the expanding partnership in energy trade.




