VCIC Receives Major Support from ADB

17 OCTOBER 2016: MANILA, PHILIPPINES

The \$631 million loan and grant support from the Asian Development Bank provides a huge boost to the 800-kilometer Visakhapatnam-Chennai Industrial Corridor (VCIC) section of the 2,500-km East Coast Economic Corridor. Approved in September 2016, the VCIC Development Program will help develop India's first coastal industrial corridor and create seamless trade links between South and Southeast Asia.

ADB Advances Harmonization of SPS/TBT Measures in the SASEC Subregion

4 OCTOBER 2016: THIMPHU, BHUTAN

The Asian Development Bank is helping countries in the SASEC subregion harmonize two technical non-tariff measures, Sanitary and Phytosanitary (SPS) Measures and Technical Barriers to Trade (TBT), to enhance intraregional trade. Under this initiative, a national diagnostic study on SPS and TBT will be conducted in each of the six SASEC member countries, to be led by core committees formed by the six governments, in consultation with trade experts.

New India-Bhutan Trade, Commerce, and Transit Agreement Approved by Indian Cabinet

27 OCTOBER 2016: NEW DELHI, INDIA

A new Agreement on Trade, Commerce, and Transit between India and Bhutan, enabling a free trade regime between the two countries, and providing for duty-free transit of Bhutanese merchandise for trade with third countries, has been approved by the Cabinet of India, in a meeting chaired by India Prime Minister Narendra Modi.

Power Trade to Help South Asian Countries Save \$9 Billion Annually, Reduce Emissions

21 OCTOBER 2016: DHAKA, BANGLADESH

South Asian countries should engage more in regional energy trade and joint management of resources. By doing so, they could save over \$9 billion annually and reduce carbon emissions by 8%. And since energy drives development, energy cooperation and trade is expected to translate to improved standards of living and poverty reduction. This was the message at “Power and Energy in South Asia: Connectivity through Cooperation,” a training program organized by IPAG, ADBI, and United Power in Dhaka, Bangladesh.

Land Acquisition for the Agartala-Akhaura Rail Project Begins in Bangladesh

20 OCTOBER 2016: TRIPURA, INDIA

The Governments of India and Bangladesh have begun the process of acquiring land in Bangladesh to build the new India-Bangladesh railway project. The 15 kilometer (km) railway will connect Agartala (India) to Akhaura (Bangladesh), and reduce the 1,613-km mountainous distance between Agartala and Kolkata to 514 km.

Bangladesh and Nepal officials have emphasized the need to both hasten and deepen integration among South Asian countries through the Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation (BIMSTEC). Bangladesh Prime Minister Sheikh Hasina said the region must work to finalize BIMSTEC Free Trade Area Framework Agreement deals to boost trade in the region. Nepal Prime Minister Pushpa Kamal Dahal stated that BIMSTEC can be a dynamic engine for growth and development.




