SASEC Working Groups in Transport and Cross Border Power Trade convened meetings in October to discuss the way forward in cooperation as reflected in the draft Action Plan for SASEC Initiatives 2021–2023. The <u>Transport Working Group</u> presented and reviewed the proposed initiative to leverage digital technology under the "new normal," in light of economic disruptions caused by the coronavirus disease (COVID-19) pandemic, and the studies on Road Safety and Asset Management. The <u>Cross Border Power Trade Working Group</u> reviewed the way forward in SASEC Energy/ Power Cooperation, and progress and proposed activities under the SASEC Regional Energy Cooperation.

21 October 2020: Online

The virtual workshop's aim is to help customs authorities better understand the benefits and impact of coordinated border management in enhancing trade facilitation. Coordinated border management improves regulatory effectiveness, particularly during critical periods.

The strategy, which covers the period 2020–2024, will support Maldives in its response to the COVID-19 pandemic. It will also help ADB continue gender mainstreaming in its operations in the country.

Indian Market Access, Plant Quarantine Center for Bhutanese Agri Products

21 October 2020: New Delhi, India, and Thimphu, Bhutan

The Ministry of Agriculture and Farmers Welfare of the Government of India has granted market access to Bhutan's areca nut, mandarin, apple, potato, and ginger under the Plant Quarantine (Regulation of Import into India) Order 2003. A plant quarantine center was also set up in Jaigaon, India, to ease India—Bhutan cross-border trade of agricultural goods. On the Bhutanese side, the Ministry of Agriculture and Forests of the Government of Bhutan has allowed the import of tomato, onion, and okra from India under the Plant Quarantine Rules and Regulations of Bhutan 2018.

Bangladesh, Nepal Negotiate Draft Preferential Trade Agreement

9 October 2020: Dhaka, Bangladesh, and Kathmandu, Nepal

The Governments of Bangladesh and Nepal held a secretary-level meeting virtually to negotiate a preferential trade agreement. Bangladesh has requested zero-duty benefit on the export of 140 products to Nepal. Nepal has proposed duty-free facility for 130 products. The negotiation also discussed important initiatives that can further increase bilateral trade, such as boosting connectivity and removal of tariff and nontariff barriers in trade.

5 October 2020: Thimphu, Bhutan, and New Delhi, India

The Ministry of Foreign Affairs of the Government of Bhutan announced an Air Travel Bubble Arrangement with the Government of India. The arrangement makes flight operations possible between the two neighboring countries until normal operations of international flights resume.




