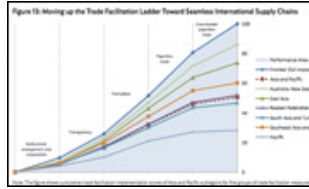

## **New ADB Country Partnership Strategy to Accelerate India's Transition to Upper Middle-income Status**

**27 September 2017: Manila, Philippines**

The Asian Development Bank endorsed a new India Country Partnership Strategy 2018-2022 that ramps up annual lending support to a maximum of \$4 billion a year to fast-track India's inclusive economic transition toward upper middle-income status. It focuses on three pillars: enhancing economic competitiveness, improving access to infrastructure and services, and addressing climate change and improving climate resilience.

## **Freight Train Service to Run for Dhaka-Kolkata**

## **RFID Technology Boosts Indian Port Productivity**

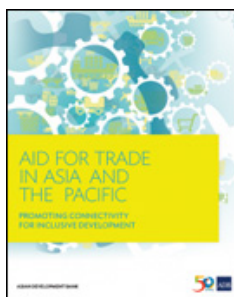

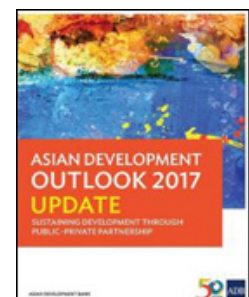

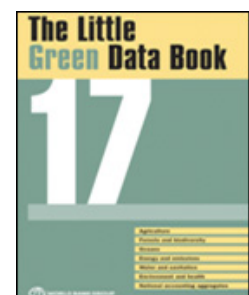
