ADB to Provide around \$5 Billion to Bangladesh

11 September 2019: Dhaka, Bangladesh

ADB handed over to Bangladesh Prime Minister Sheikh Hasina ADB's Country Operations Business Plan for 2020–2022. The plan programs around \$5 billion in projects in three years to promote sustainable growth in Bangladesh, and prioritizes skills development participation in global value chains through the SASEC partnership.

10 September 2019: Colombo, Sri Lanka

Construction of Colombo's first elevated highway commenced. Sri Lanka Prime Minister Ranil Wickremesinghe laid the foundation stone to mark the start of construction. The ADB-supported project will help alleviate traffic congestion in Colombo's densely populated areas, improve last-mile connectivity between the country's expressway network and Colombo's international port, provide better logistics services for freight operations, and facilitate regional trade.

The Government of India plans to implement a National Logistics policy to help bring down the logistics cost by 10%, according to Mr. Piyush Goyal, Minister of Commerce and Industry and Railways of the Government of India. The proposed policy was sent to the Cabinet for approval.
